The shortlisted candidates of the Main Merit List may deposit the prescribed semester fee of Rs. **13000/- (Admission Fee: Rs. 11000.00/-, Local Fund: Rs. 1500.00/- and Caution Money: Rs. 500.00/-)** through online payment gateway (link is available on Online Admission 2023 portal on the main page of the University website i.e. www.uok.ac.in) from the **07 - 10 September 2026** after due verification of the documents. The last date of document verification and subsequently fee deposition is **10 September 2026**.
2. The shortlisted candidates of the Waiting List may also deposit the prescribed semester fee of Rs. **13000/-** through online payment gateway during the above-mentioned dates after due verification of the documents. The admission of the waitlisted candidates will be considered if candidates from the main merit list do not deposit the prescribed semester fee up to the last date of fee deposition. The provisional admission of waitlisted candidates will be confirmed after the last date of fee deposition.
3. The eligible candidates of main merit list as well as waiting list will submit the self-attested copies of all the required original documents such as marks sheets of qualifying examinations, TC & CC, board certificate, migration certificate, bonafide certificate, caste certificate, EWS, PH, NCC, NSS, sports & games certificates to the Course Coordinator for the verification before the last date i.e. **10 September 2026** of fee deposition.
4. The candidature of the provisionally included candidates in the main merit list and waiting list will stand cancelled, if the candidates fail to deposit the prescribed semester fee in the given time schedule as mentioned above (Point 1/2).
